PRESS COMMUNIQUE.

In continuation of Foreign and Political Department Press Communiqué dated Delhi, the 5th January 1927, published above, it is announced that the Persian Government now insist on all passports for Persia being visaed by their Consular Representatives in India. All intending travellers to Persia by the Nushki Extension Railway are accordingly informed that they should have their passports visaed by one of the Persian Consular Representatives at Calcutta, Bombay or Karachi before proceeding to Quetta. All intending travellers to Persia via Quetta can have their passports visaed by the Persian Passport Officer at Quetta.

As much inconvenience is caused to the Government of Bombay by persons not resident in the Bombay Presidency, proceeding to Bombay and applying for passports to that Government, all intending applicants for passports from this province are warned that they must obtain passports locally before proceeding to Bombay.

It is notified for general information that all Afghan Consular Representatives in India are empowered to grant visas on passports for Afghanistan without reference to the Consul General for Afghanistan in the first instance.

No. 99. — In exercise of the powers conferred by section (2) of the Indian Tolls

Act, 1851 (Act No. VIII of 1851), as subsequently amended, enabling Government to levy tolls on public roads and bridges, the Local Government is pleased to direct that the following amendments shall be made in the Local Self-Government Department's Notification No. 3156-1735-VIII, dated the 4th July 1929:—

Amendments.

(i) The "Note" under the "Schedule of rates of tolls" shall be numbered 1 and the following shall be inserted as Note 2 below it:—

"NOTE 2.—When counting young animals, odd numbers, if any, should be neglected."

(ii) The sub-paragraph "The toll leviable in respect of a vehicle twice the toll prescribed" shall be numbered 2 and thereafter the following shall be inserted:—

"3. The toll leviable in respect of a vehicle or animal for any number of journeys in one month, may be compounded by payment of two-thirds of the toll due for the month."

(iii) The full stop at the end of clause (c) under "Exemptions" shall be altered to a semi-colon and thereafter "also police officers in plain clothes on duty, on production of a certificate signed by the District Superintendent of Police" shall be added.

(iv) Below clause (c) under "Exemptions" after amending as above, the following shall be inserted:—

"NOTE.—A motor lorry conveying a policeman in uniform will not be exempted from payment."

(v) The following four clauses shall be added after clause (g) under "Exemptions":—

"(h) Cars conveying Government officers stationed at Bhandara, while on duty, on production of a permanent pass signed by the Executive Engineer, Bhandara division.

(i) Carts carrying Government materials or stores, on production of a certificate signed by the Executive Engineer, Bhandara division.

(j) Bicycles of Public Works Department subordinates on production of a certificate signed by the Executive Engineer, Bhandara division.

(k) Bicycles of students living in Kardha while going to, and returning from, schools in Bhandara, on production of a certificate from the Head Master of the school in which the student is studying."
