Expression of Interest

The Superintending Archaeologist, Archaeological Survey of India, Bhopal Circle, Bhopal on behalf of the President of India invites Expression of Interest from Firm/Agency/organization for preparation of total station survey work of the surrounding 300 meter area with site plan for the protected area, the prohibited and regulated area of various centrally protected monument under jurisdiction of Bhopal Circle. The following parameters shall be adhered to & incorporated.

Parameters -:

- (i) Contouring (1 meter interval) is preferably. However it can vary depending on the nature of landscape, if it is hilly terrain with cliffs, then counter interval can be increased. If the landscape is plain, then it can be 0.5metre.
- (ii) Fixing of Bench mark and survey point on the ground and map.
- (iii) Protected area needs to be mapped in such a manner that property and feature within the area can easily be identified therefore the area shall be required to be grided both on the map and round. Grids can be of 50x50metres.
- (iv) Mapping of structures, building etc. on plan surrounding 300 meter from protected area.
- (v) Other features like tank embankment, mud fortification remains of ancient structure etc. should be shown.
- (vi) Roads and pathway.
- (vii) Garden area.
- (viii) Trees
- (ix) Telephone lines.
- (x) Sewerage lines.
- (xi) Water supply line etc.
- (xii) Contouring / Relative heights of certain area.
- (xiii) Final work should be submit on A 1 size printout both on film and paper (paper not less than 100GSM)
- (xiv) Colour print 2 nos each.
- (xv) Black & white print 2 nos each.
- (xvi) Soft copy in autocade & in PDF format
- (xvii) Data input in excel sheet.
- (xviii) Map has to be co-ordinated with GPS co-ordinate.
